



Electric Vehicle Charging Points – Access Application

This form should be used if you wish to apply for an access key to use the 36 public charging points installed as part of the CABLED (Coventry And Birmingham Low Emission Demonstrators) project.

The key will be valid until the 31st December 2010 and prior to this E.ON will inform you of arrangements for using the CABLED public charging points after that date.

An application fee of £25 is payable to cover the cost of the key. For an initial period electricity supply will be provided free of charge, however this may be reviewed at any time.

Terms and Conditions for Use of Elektromotive Public Charging Points in the CABLED Trial

These terms and conditions are made between E.ON Engineering Limited registered in England and Wales No. 02902387 registered office: Westwood Way, Westwood Business Park, Coventry, CV4 8LG ("We") and the electric vehicle user ("You").

These terms and conditions set out your responsibilities when using public charging points to re-charge your electric vehicle. Please read the following carefully and sign below to confirm your acceptance. On receipt of your acceptance We will send an electronic access key to your home address, so that You can use the CABLED public charging points

- 1) Use of the charging points is restricted to road legal electric or plug-in hybrid vehicles, bearing a recognised registration number.
- 2) You shall be responsible for complying with the parking restrictions at each parking site as these may vary on an individual basis.
- 3) You shall be responsible for following the instructions in the Elektrobay User Instructions Leaflet.
- 4) You shall be responsible for ownership of the electronic access key once it is in your possession. In the event of damage to or loss of the electronic access key You will be required to pay a replacement cost of £25.
- 5) The access key will be valid until 31/12/2010. Prior to this date, E.ON will inform You of arrangements for using CABLED public charging points after that date.
- 6) You shall be responsible for ensuring that the re-charging of your electric vehicle is carried out safely so as to avoid injury to any person or damage to property. In particular You must ensure that:
 - You only use the cable that your vehicle manufacturer supplied You with
 - The cable is safely plugged into your vehicle and that the positioning of the cable does not create a tripping hazard for passers-by;
 - You never unplug the cable from the vehicle before removing the plug from the charging point;
 - You never drive off with the cable still attached to the electric vehicle charging point.
- 7) You shall be responsible for ensuring that your connection cable is stored safely and maintained in good condition. In the event of a damaged cable, You must refer to the supplier's instructions. You must never use a cut or damaged cable. You must never repair the cable yourself.
- 8) You shall only recharge your vehicle while correctly parked in a designated Electric Vehicle Parking Bay.
- 9) We offer no warranty as to the availability or operability of the charging points or the power supplied from them.
- 10) We reserve the right to remove the charging points without prior notice.
- 11) If You are found to be misusing the charging points You will be held liable for any damage caused and could have your electronic access key deactivated.
- 12) In case of fault with the CABLED public charging point there will be a contact number located on the charging point.
